### NEWMARKET POLICE RIDE-ALONG RELEASE AND WAIVER

Dear Ride-Along Applicant,

If you are at least 16 years of age, you are welcome to apply for a ride-along by reading, completing and signing both pages of this Ride-Along Request Form. If you are under 18 years of age, a parent must sign the Parental Consent Release.

As evidenced, by your signature on page two of this form, you are agreeing not to discuss or disclose any person's personal information observed or heard while participating in the Newmarket Police Ride Along Program. This confidentiality and non-disclosure agreement includes, but is not limited to, criminal histories, motor vehicle information or anything gained from an ongoing or past police investigation.

Any breach of confidentiality or disclosure of any such information is a misdemeanor and by signing this document, you state that you are fully aware of this fact and will be subject to criminal prosecution as well as possible civil liability for any such breach. You by signing, state that you are also aware that Federal as well as State Statues governing the privacy of an individual's records will also be violated by such breach or disclosure.

As part of this program, by signing the attached waiver, you agree to undergo a comprehensive police records check.

#### Your basic responsibilities as a ride-a long are to:

Remain in the police vehicle.

Limit your movements to places you have permission to enter.

Comply with all directions given by a police officer.

Avoid operating all police equipment, unless an officer's safety is at risk or you are directed by an officer to do so.

You will be an observer only. Do not become involved verbally or physically unless the officer's safety is at risk or you are directed to do so. The Town of Newmarket will not be liable for a ride along's unauthorized interventions.

You must be in civilian clothing and dressed appropriately.

You cannot carry a firearm even if you have a concealed weapons permit. The exception to this is if you are a certified police officer.

The personal safety of the officer and the Police Departments responsibilities to the community will be considered at all times. Therefore, an officer may terminate your ride-along at any time, without explanation or advance notice. In addition, if emergency circumstances dictate, you may be dropped off at a safe location in the fields.
