1. 6:45 PM Non-Public Session pursuant to RSA 91-A:3.II(e) - Legal - Pending Litigation

Chair Conley convened the meeting at 6:45PM.

2. Pledge of Allegiance

Chair Conley reconvened the meeting at 7:04 PM and led the Pledge of Allegiance.

3. Roll Call

4. Election of Officers, Adoption of Town Council Rules, and Committee Assignments

a. Elect Council Chair

Motion: Councilor LaMattina made a motion to Nominate

Councilor Katanna Conley as Chair

Second: Councilor Ward

Discussion: Councilor Ward made a motion to nominate Councilor Joe

LaMattina as Chair. Councilor LaMattina withdrew the

nomination.

Vote: Unanimously Approved (6-0-0)

b. Elect Council Vice-chair

Motion: Councilor Dornblut made a motion to Nominate Councilor

Brian Ward as Vice-chair.

Second: Councilor LaMattina

Vote: Unanimously Approved (6-0-0)

c. Adoption of Town Council Rules for 2024/2025

i. Proposed Amendment to Rules of Proceedings

Motion: Councilor Ward made a motion to approve the 2024/2025

Council Rules of Preceedings as amended.

Second: Councilor LaMattina

Discussion: Town Manager Fournier explained the proposed changes

to the rules. Communications - do not read letters at meetings. Acknowledge the letter and place on file unless the Council asks that the letter be removed from the table for discussion. Enforce the rule that during public forum only allow public comments on the agenda items. He explained that there is an unwritten rule that the Vice-chair makes the motions for all action items, making it easier for

recording purposes.

Discussion ensued, and the Council agreed that there would be no changes to public forum procedures. Residents will continue to be allowed to speak on any topic for 3 minutes or longer if the Council votes to allow it.

Councilor Blackstone proposed the following amendment to the rules: when the Council receives a new application, not a renewal, for a committee, the Council will first send that application to the Chair of that Committee and ask them for a recommendation. Upon receipt of the recommendation from the Committee, the Council will vote on the candidate, taking into consideration the Committee's recommendation to all for smoother transition of the candidate and the Committee.

Discussion ensued and a change was made that the Council will provide a copy of the candidate's application to the committee chair, offering them the opportunity to "weigh-in" on the application to the Council.

After further discussion Town Manaager Fournier

suggested adding a line to the

committee/board/commission application to read: While attendance at the Council Meeting for your appointment is not mandatory it is highly recommended. The Council may give their nomination at such time as their questions have been addressed. This process is not an amendment to the Rules; it is a practice the Council will engage in going

forward.

Vote: Unanimously Approved (6-0-0)

Motion: Councilor Ward made a motion to amend the rules to

change the order of the Agenda by moving Nominations, Appointments and Elections under Acceptance of Minutes.

Second: Councilor LaMattina

Vote: Unanimously Approved (6-0-0)

Town Manager Fournier reminded the Councilors that they may submit

ordinances and resolutions to the Council for approval and that the staff will help them write them.

Councilor Dornblut asked if there was an update to the urban compact conversation. Town Manager Fournier said that there is discussion at the state level. Local Department of Transportation (Division 6) has concerns. The Town Engineer checks weekly for new developments.

Discussion: Councilor LaMattina said that Ms. Wolfe currently sits on

the Committee and he highly recommends her

reappointment.
