Councilor Jarvis explained that there had been questions regarding the union negotiations and whether the issue could be discussed publicly yet. She read a letter from McKittrick Law Office stating that the information and discussions were not able to be made public yet and that Councilors should not engage in conversation with Union Representatives regarding the issues. The Union had declared an Impasse at the last bargaining session. Mr. Gary Altman would be called in to mediate.

**Councilor Glennon** stated that he had received several phone calls from police and that someone needed to tell them that was inappropriate and should not be happening.

The Council discussed the reasons the negotiations have taken so long and the items that the negotiations were stuck on.

**Councilor Jarvis** stated that Councilor G. Hamel, Administrator Dixon and Councilor Hart would be the negotiating team. She would attend the first meeting in order to get a handle on how they were conducted. She stressed that the negotiations needed to be fair across the board.

Councilor G. Hamel stated that the major stumbling blocks they were hitting were health insurance, private detail pay, binding arbitration, electronic transfer of salary and wages.

Administrator Dixon suggested that if the Council was going to look at a menu for health insurance that they start now.

The Council discussed health insurance options at length.

**Administrator Dixon** stated that Clay Mitchell had initially approached him about the possibility of ball fields in the front of the Kwaks property.

The Council discussed whether ball fields would work at that location, whether the town would be interested in acquiring the open space and the possibility of reserving the right to run a water line diagonally through the property if the groundwater recharge worked.

Administrator Dixon stated he would set up a time for a site walk where Rose-Anne Kwaks, Clay Mitchell and Councilor Jarvis could attend.

**Councilor Jarvis** if the Council was comfortable authorizing the Town Administrator to write a letter to Rose-Anne Kwaks requesting more information regarding covenants and restrictions as mention to Councilor Jarvis.

The Council agreed they were comfortable with that authorization.

**Councilor Jarvis** reminded the Council not to enter into any discussions with Rose-Anne Kwaks about the issues.
