Phil Lepage approached Chair about flying the POW/MIA flag daily at the White Memorial site. Committee agreed that the flag would be purchased at Mr. Lepages cost and also any work that needed to be done to ropes to allow two flags to fly. Committee felt that seeing Mr. White was not a POW/MIA that flag could fly on restricted dates being POW/MIA day: 3rd Friday in September, Veterans Day (Nov. 11th), Armed Forces Day/Memorial Day (May 19th and May 30th
