# 5. Treasurer's Report

**Ann LaFortune**, Treasurer reported on the financial report from Sept-Dec 2018. The next quarter is unavailable at this time. The Schoppmeyer Park fund currently holds \$19,606. The total Conservation Fund holds \$310,927.50. The new Heron Point Gate charge is not listed on this report, but the \$2,275 has been paid. Other expenses approved in the fall do appear on this report. This is the final meeting for **Ann LaFortune** and the Conservation Commission would like to thank her for her great contribution to the Conservation Commission and the Town. She will be missed!

## 6. Committee and Subcommittee Reports

<u>Town Council</u>: Casey Finch is not present this evening. The Chair reported that the Macallen Dam will be repaired. The CC wrote a letter to NHDES to support the Wetlands Permit requested by GZA for the rehabilitation project in January 2019.

<u>Planning Board</u>: Sarah Finch announced that she had nothing to report as the Planning Board meeting last month was cancelled due to weather. The next meeting will have a heavy agenda.

## 7. Chairman's Report

<u>Newsletter from NHDES:</u> The Chair received a newsletter from the NHDES Water Trust Fund Projects. The Town of Newmarket received funding from the Trust last year for New Road main replacement (<a href="https://www4.des.state.nh.us/nh-dwg-trust/wp-content/uploads/2018/09/Final-Funding-List-as-voted-8-30-18-2.pdf">https://www4.des.state.nh.us/nh-dwg-trust/wp-content/uploads/2018/09/Final-Funding-List-as-voted-8-30-18-2.pdf</a>). Funds for this Trust come from a nationwide gasoline additive settlement and are being used for drinking water funds and, possibly in the future, ground water protection.

<u>Request for Use of Schanda Park:</u> LOCO Sports LLC is requesting the use of Schanda Park for the 13th Annual Great Bay Half Marathon & The Center for Orthopedics & Movement 5k (<a href="http://greatbayhalf.com/">http://greatbayhalf.com/</a>) They have been very careful about the clean-up in the Park every year.

**SCA (Student Conservation Association) New Hampshire AmeriCorps:** The Chair received information from NH AmeriCorps notified the CC that 6-7 member crews are available for projects including work on trails, invasive species removal, habitat restoration/planting, erosion control, and stream bank improvement. The Chair suggested both Wiggin Farm and Piscassic-Loiselle. He will draft a request to discuss with members. The volunteers may spend up to 10 days on a project. More information is available at:
