CONSERVATION COMMISSION April 8, 2021 7:00 PM Virtual Meeting Called to Order: 7:05 PM

3. Public Comments

No comments this evening from the public.

4. Guest Presentation- Welcome!

Brian Groshon, Operation Manager Trainee, Casella Waste Systems, Inc., is our guest this evening. He discussed the significant change in the recycling market over the past three years. In 2017, China banned mixed fiber through a program they called "National Sword". Everyone in the recycling business needed to find new outlets for collected materials...the cost went up and the quality of the product went down. In Newmarket, the collections each week are off loaded in Allenstown and transported to Charlestown, MA where the mechanical process to separate cardboard, tin, aluminum, and plastic takes place as Casella uses 'single stream'. Their educational materials like to focus on items which can be recycled rather than those that cannot. Glass is important, but the process of sorting produces crushed glass. Recently the only plant that accepted crushed glass in MA shut down. Casella is now working with a construction company in MA to use the crushed glass as an aggregate for construction. The USDOT discusses the use of glass for roads here: https://www.fhwa.dot.gov/publications/research/infrastructure/structures/97148/wg2.cfm Mellisa Brogel mentioned the new recycle 'rollies' in Stratham. Brian reported that Statham did an RFP for automated collection and they got a better rate in the process. Through the 'Recycling Partnership', each household would pay \$15 per cart. The carts are made of 40% recyclables, they have a 10 year warranty, but can last up to 20 years. Casella would only need one man per truck instead of two. Ellen Snyder asked how we can reach out to the community to make it clear what should and should not go into the bin. Casella suggests using flyers, promoting the video on DCAT, and all of our social media outlets for the ConCom. Casella has wonderful videos available at their website and everyone is encouraged to check them out:

5. NHDES Permit Request for 60 Grant Road

Jim Gove, President of Gove Environmental Services, Inc., is here this evening to describe the property at 60 Grant Road and the request for an NHDES dredge and fill permit in an isolated wetlands area. The lot is a long, narrow lot of 10.3 acres that goes back to the Piscassic River. DOT was asked to approve the driveway cut onto Grant Road. However, DOT requires a site line of 400' in either direction. Unfortunately, where the driveway was placed on the original plan provided less than 200'. James Hewitt, from DOT, is mandating that

the driveway be moved down to make the 400'. Unfortunately, this will cut across 235 sq.ft. of isolated wetlands and require the owner to apply for a dredge and fill permit. **Melissa Sharples** asked about the granite ledge and the position of the house. Jim explained that all of his test pits were good and that he feels that the house is located appropriately for the lot. Jim also mentioned that he has worked with Amy Lamb at NHB regarding the special species found on this property. Fish & Game was also contacted and they just want to make sure that there is a 100' set back from the Piscassic River. This is a standard application and the ConCom should send a letter to NHDES commenting on the permit. In an answer to **Ellen Snyder's** question about the possibility of future subdivision, Alexx Monastiero, Realtor with The Gove Group Real Estate LLC, stated that she did not believe that the back portion would be considered for further development as it is very uneven and composed mainly of granite ledge. In addition, a lot cut out in the back would be landlocked and could not be sold. **Ellen Snyder** feels good about the placement of the house and the minor impact on the wetlands with this application.

6. Heron Point Management Plan

Jon Martin, from Martin Forestry Consulting LLC, and his assistant Greg are here this evening to discuss Heron Point. Ellen Snyder introduced them and said she had been out to the site with Greg to assess the trails. Jon sent us a standard landowner objectives form. He visited the Point in March for a timber cruise to get a basis for mapping and estimating growth volumes. He observed two timber stands. He also observed that much of the timber had been harvested. Good news - black birch poles are coming into the cleared area. There was a beautiful barred owl that hung out over his head while he was assessing some of the invasives - he never moved. The hemlocks are infected with woolly adelgid and the multiflora rose has really taken over. The Chair asked about whether or not we should take down the dead trees nearest to the walkway/decking. Jon suggests that we remove the trees that are within striking distance of the trails, but leave the rest to maintain habitat for wildlife. Greg is currently getting the recreation portion of the plan together. Jon recommends opening the over story a bit to encourage song birds and encourage small mammals. Commercial forestry is difficult because of the big equipment necessary. Ellen Snyder described the deed which gives the reasons for establishing Heron Point as 1) scenic beauty, 2) contemplation/ meditation, 3) wildlife habitat, 4) fishing, 5) launching a kayak/paddle board, and 6) bird watching. The Chair would like to plan a site walk with Jon and Greg. Megan Brabec will check the current information on the allowable meeting numbers for outdoors. We may have to post the meeting. 9. Treasurer's Report

Ellen Snyder reports that no current use funds were deposited. The General Fund balance is \$827.90. The Conservation Fund balance is \$245,375.90 which includes the Schanda Fund. We received \$44.14 in interest. Expenditures were \$4,800.00 for the John Brown Co. for the work completed at Wiggin Farm. We will receive partial reimbursement from Fish & Game of \$3,150 for that work. Expenses in the cue include the \$2,500 for the Heron Point Management Plan and the \$75,000 for the Clarke Farm Easement.
