The Newmarket Conservation Commission is pleased to provide this letter of support for the Town of Newmarket's Sewer Reliability Improvements Project.


The Conservation Commission is aware of the sewer leak that was discovered in May 2023 in the existing sewer forcemain that extends from Bay Road, under the Lamprey River, and on to the Wastewater Treatment Plant. This sewer line dates to the 1960s and is situated in an ecologically sensitive area. Since the leak was discovered, the Town has been proactive in implementing emergency repairs and seeking long-term, sustainable solutions.

The Conservation Commission has been working collaboratively with our Town Departments to protect and steward the natural resources and ecological assets of our community. We are fortunate to have these effective and rewarding partnerships that solve problems and benefit our community. It is in this spirit that we support our Wastewater Department in their efforts to upgrade this critical infrastructure, while protecting water quality and the ecological health of the Lamprey River and the Great Bay – for people and nature.

Ideally, a new sewer forcemain can be constructed along roads, instead of under the Lamprey River. To ensure that our community can implement the best possible solution, the Town of Newmarket seeks your help in finding the funds to implement this critical and time-sensitive infrastructure upgrade. We ask your support of this project via the Congressionally Directed Spending through the Appropriations Committee process.
