Any person, organization or corporation who violates any of the provisions of this chapter may be fined not less than \$100.00 for each offense.

The Licensing Board, at its discretion, may require additional conditions at no cost to the Town to include, but not limited to, an insurance binder that names the Town of Newmarket as an additional insured, police or fire details, or other measures to ensure the public safety.
