We are selling a propane fired Onan generator located in the Sally Port at the Newmarket Police Station. The generator was operational when taken out of service but we are not providing warranty or guarantee that the unit operates. The Generator has been located inside and out of the weather since its installation at the Police Station. The unit cannot be started as it has been disconnected form the fuel source. The generator is being sold as is and where is with no express warranty. The successful bidder is responsible for removing the generator from the space. Access for removal must be coordinators with the Town of Newmarket as it is located in a secured property

The successful bidder shall provide payment funds made out to the Town of Newmarket within 10 days of acceptance of your submission. The generator must be removed from the Police station within 10 days of received payment.
