5. Report of the Town Manager

a. Town Manager's November 2, 2022 Report

Election Day: Election Day is Tuesday, November 8 from 7AM to 7PM at the Newmarket Jr./Sr. High School. The majority of Councilors should be present since it is anticipated that there will be a large number of voters.

FY23 Tax Rate: The State of New Hampshire Department of Revenue Administration (DRA) has set the property tax rate for the fiscal year ending June 30, 2023, for the Town. The tax rate is \$26.99, an increase of 63 cents per thousand of assessed valuation or 2.4%. Town: \$6.27; Local School: \$18.36; State School: \$1.42 and County \$0.92. Tax Bills will be issued soon with a due date of December 5, 2022.

Right to Know Law Policy: Pursuant to Ordinance 1-43 the Town Manager is enacting a Right to Know policy. The policy is intended to provide town personnel with guidance regarding the requests of citizens and others for information. All requests for information per RSA 91-A should be referred to or forwarded to the Town Manager's Office. The intent is to have one point of contact with our offices and one point of information dissemination.

FY23 Expense and Revenue Report: At the end of September, 30% of the operating budget has been expended, which is normal for this time of year. The Town Manager is concerned with overtime in the Fire Department and will continue to monitor it. Revenues are on target with motor vehicle registrations slightly lower than last year and building permits more than doubled.

6. Committee Reports

Councilor Ward reported on the CIP meeting:

The CIP Committee met with the school. The school is looking to renovate the High School and Elementary School, replacing tiles and carpets and windows. At some point, they would like to make upgrades to the athletic fields. They also want to do a playground study. The Committee agreed to the playground study and decided they needed more information on the roof and building system upgrades they would like to do. The school currently has enough money in their capital reserve fund to fund those upgrades.

Councilor Brabec reported on the Arts & Tourism Commission Meeting:

The Commission met last night. They have a new free library at Lamprey Health Center "Mother Goose on the Loose" with plenty of children's books. The pop-up library is generated by the Rotary Club. The Chair met with Eric Chinburg to discuss updates to the Elm Street Wall. They are going to get masonry quotes. The library is involved because they will be making some changes to the library side and would like it all to flow aesthetically. She said a question came up at the meeting regarding Ad hoc in the Commission title. Town Manager Fournier said that it was not intended for the Commission to sunset and that Ad hoc does not make a difference to the Commission's charge. Councilor Brabec reminded everyone that there is an open seat on the Commission.
