Councilor Glazebrook reported on the January 2nd Arts, Culture & Tourism Commission meeting:

Community Development Director Bart McDonough attended the Commission meeting to discuss the Master Plan. The Commission decided to devote their March meeting to work on the Master Plan. The Lamprey River Advisory Committee (LRAC) has grants available, and the Commission intends to apply for a \$7,500.00 grant from them to acquire more funding for Willey Park.

Councilor LaMattina reported on the NH Community Power Coalition:

The week of January 22nd, Newmarket residents will receive a mailing stating that they are being switched to Newmarket Community Power and how they can OPT-OUT if they choose. In March 2024 residents will be switched over to Newmarket Community Power and April 2024 residents will receive their first bill.
