Chair Rosa brought the meeting to order at 7pm welcoming guest Bill Ernest, Sons of the American Legion Squadron 67 Adjutant/Past Squadron 67 Commander.

Mr. Ernest updated the committee on what Squadron 67 has been doing over the years as far as flagging Veterans graves for Memorial Day and cleaning up out-lining cemeteries located on private properties in Newmarket. There are a total of 47 Veterans that are buried in a total of 45 such cemeteries in town.

Mr. Ernest approached the Committee with thoughts from the Squadron of working together to give many of these cemeteries the much needed T.L.C. they deserve. Many of the graves/cemeteries are over grown and some graves are not even visible. The Squadron has cleaned a few already and hopes to do several more each year.

Mr. Ernest also was looking for some pointers perhaps or ideas on how to "map out" these locations for generations of SAL members to come so everyone knows where these cemeteries are. Many are listed by family name from years ago.

Mr. Ernest and the Committee had a great discussion and many ideas were tossed out there. The thought of a portable GPS unit with longitude and latitude for easier mapping was discussed. The committee will check with some local hikers that may have one that the SAL could possible use for this great project. Website "Google Earth" was also suggested.

Wayne has the contact information of the Willey/Carter home owners, where there is a cemetery behind that location in dire need of some TLC. This one in particular is an upcoming project this year for the SAL. Wayne will get that information to Mr. Ernest.

Committee thanked Mr. Ernest for all the work the SAL has done to date and look forward to working together in the future. Chair Rosa thanked Mr. Ernest for taking the time to attend our meeting.

Old Business: Vice Chair Nazzaro made a motion to accept the minutes as read for July 17, 2012. Motion seconded and passed with one abstention. (Patrick Marsh - excused)

John spoke on the upcoming dedication for the GAR Memorial to take place on Sat. Sept. 22nd at 9:30am. Needed items: PA system and flowers.
